### **Biography**

Dr. Gottlieb was born and raised in Long Island. He graduated with thesis honors in biology from Union College in Schenectady, NY, and then attended dental school at the University of Buffalo, where he received many academic scholarships, awards, and fellowships. Dr. Gottlieb went on to a two-year post-graduate residency program at Long Island Jewish Medical Center. At the Medical Center, he received advanced training in dental anesthesiology as well as in all specialties of dentistry. That included but was not limited to advanced training in root canals, oral surgery, dentures, and cosmetic dentistry. He is a leading authority in IV (intravenous) and oral sedation, and the founder and C.E.O. of Affordable Dental Products, Inc. Dr. Gottlieb is on staff at Stony Brook University Hospital and was recently awarded one of the top providers of continuing education in dentistry today.

### **Course Description**

Pain management, identification of addiction, and guidelines for prescribing or dispensing opioids is a 3-hour lecture that covers all the material to satisfy the New York State continuing education requirement. This program is designed for all prescribers of controlled substances, from the residents to our veterans about to retire. Through literature reviews, case studies, and professional experience, participants will understand their role in combating the current opioid epidemic.

- Understand state and federal requirements for prescribing controlled substances.
- Develop a comprehensive pain management plan.
- Utilize evidence-based and appropriate prescribing practices.
- Apply best practices for managing acute pain.
- Understand the principles and scope of palliative medicine.
- Identify strategies for prevention, screening, and early recognition of addiction.
- Describe effective responses to substance abuse and addiction.
